Digital Assets in Europeana: 166,799 (on 16 April 2018)

Funding

Since 2008, Switzerland has contributed €15, 000 to the funding of Europeana. To date, Europeana did not contribute to the funding of Europeana projects in Switzerland.

Participation in projects

Currently there are no Swiss partners in EU-funded projects that contribute to Europeana. The projects directly support to knowledge and technology sharing between libraries, museums, archives, software agencies and university research departments. The activities include delivering content, technology and knowledge to Europeana. It would be a positive outcome if we could get our Swiss partners to participate in this.

Aggregation to Europeana

Europeana Collections has over 50 million records of which 166,799 are provided by Swiss Institutions. Most records are provided by LoCloud and HOPE – Heritage of the People's Europe. Data Partners

Openly Licensed Data

9.8% of the 166,799 objects in Europeana provided by Switzerland is openly licensed³. In the case of Switzerland these records are all licensed under CC0⁴. Openly Licensed data is important as it allows contribution of content to education, Creative Industries, exhibitions and the like.

Web Traffic & Usage on Europeana Collections coming from Switzerland

The strategy of Europeana⁵ is to increase use of cultural heritage data by placing the material where users are. This does require the data to be under an open license in the main so that education, research systems and creative industry users can access automatically.

Highlights

The Europeanana Network Association is a dedicated group of experts working in the field of digital heritage. To this date 19 people from Switzerland have registered to become a Europeanana Network Association Member.

Every year the Europeanana Network Association elects the Members Council consisting of 36 members who play a crucial role across all Europeanana's activities.

Also the Members Council appoints six members to form its Management Board, who sit on the Europeanana Governing Board and represent the Network in the Europeanana Foundation's executive decision making.
