Datasets processed in project to date

The project partners' metadata sets are being processed by The European Library as per the Metadata Ingestion Plan (available via Basecamp and Europeana Pro).

Particularly the institutions aggregating metadata from a variety of sources, and then passing it on to Europeana are experiencing great difficulties in complying with the demand for full and consistent rights labelling. This why data processed by The European Library is not always included in Europeana.

Often they would wish to use the rights label 'unknown'. Data thus labelled in not current accepted in Europeana. It is explored whether this ruling could be reviewed.

All records processed during this process and held in the database of The European Library will be available in the Europeana Cloud infrastructure and are therefore in principle available for the Europeana Research facility for scholars, academics and researchers that is developed in this project.
